

**Fairfield Township
Regular Board Meeting – Township Fire Hall
September 13, 2021**

The meeting was called to order at 7:00 pm by Supervisor Chris McCallister followed by the Pledge of Allegiance.

Fire Department – Failed Hose – McCallister made a motion to have the Fire Department take an inventory of hoses (brass/aluminum)/lengths and sell 50 ft sections for \$5, having all inquiries taken at the Township Office,

second by Keller. Roll call vote: Comar – yes, Zenk – yes, Green – yes, McCallister – yes, Keller – yes. Motion passed.

Zenk made a motion to adjourn, second by Green. Meeting adjourned at 7:48 pm.
