Fire Report – Fire report was given to Board by Chief Rank. Chief Rank announced that he will be retiring and moving to Florida on January 11, 2022. He also reported that Jamie Norman and Brandon Bryan have turned in their resignations due to moves. Jamie is working with Adrian Township and Brandon is with Raisin.

Stop Sign at Ovid & Jefferson – McCallister made a motion to install two Stop signs at intersection of Ovid & Jefferson. Motion lacked support.

Review Road Projects – McCallister moved to table discussion until December, second by Keller. Roll call vote: Zenk – yes, Green – yes, Keller – yes, McCallister – yes. Motion carried.

Resolution 2021-02 – Approval of Fire Equipment Repairs by Supervisor – Zenk moved to make the limit \$4,000, second by Green. Roll call vote: Zenk – yes, Green – yes, Keller – yes, McCallister – yes. Motion carried. Resolution was offered by McCallister, supported by Green. Roll call vote: Zenk – yes, Green – yes, Keller – yes, McCallister – yes. Resolution passed.

Appointment – BOR – McCallister moved to appoint Kevin Keller, Allen Croll, Norm Emmons, with Cindy Croll as alternate, to the Board of Review. Second by Zenk. Roll call vote: Zenk – yes, Green – yes, Keller – yes, McCallister – yes. Motion carried.

ARPA Ideas – McCallister asked for Board to start thinking of ideas for the American Rescue Plan Act monies.

Keller moved to adjourn, second by Zenk. Meeting adjourned at 9:40
